

RESOLUTION NO. 4867

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, CASTING VOTES FOR NOMINEE(S) FOR THE BOARD OF DIRECTORS OF THE TARRANT APPRAISAL DISTRICT FOR A TWO-YEAR TERM BEGINNING JANUARY 1, 2025.

WHEREAS, the current terms of service for the five elected directors of the Tarrant Appraisal District expire December 31, 2024; and

WHEREAS, there are fourteen (14) nominees for the five positions; and

WHEREAS, those selected will begin a two-year term effective January 1, 2025; and

WHEREAS, the City of Keller is entitled to cast twenty-two (22) votes either collectively or separately for the nominees; and

WHEREAS, it has been determined by the City Council of the City of Keller, Texas, that it is in the best interest of the citizens of the City of Keller, Texas, for the City Council to cast its votes for the following nominee(s) to the Board of Directors of the Tarrant Appraisal District.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the Mayor of the City of Keller is hereby authorized, on behalf of the City Council of the City of Keller, to cast the City of Keller allocated 22 votes on the official ballot for the election of members to the Tarrant Appraisal District's Board of Directors.

Section 3: THAT, the following twenty-two (22) votes shall be cast for the following nominee(s) to the Board of Directors of the Tarrant Appraisal District:


